Permits are sold on a first come, first serve basis. One quarter can be purchased at a time. The Borough accepts cash, checks, or money orders for the purchase of parking permits. Debit/credit cards payments are available through our online permit portal for renewals only. Permits are non-refundable.

Permits will not be sold to anyone with outstanding parking tickets & are only valid for the vehicles listed on your application.

A one-time courtesy “VOID” will be extended for tickets issued for failure to properly hang your permit. Tickets issued after that for that reason are valid.

If Lot 5 is full, parking is permitted at any unrestricted meter on the street south of Hood Alley & Bank Alley to, & including, Ann Street, providing your permit is properly displayed on your rearview mirror.

If Lot 2 up permit spaces are full, parking is permitted at any metered space in that lot, or at any unrestricted meter south of Hood Alley & Bank Alley to & including, Ann Street, providing your permit is properly displayed on your rearview mirror.

When parking on the street for the lot which you have a permit, please either move your vehicle back into the lot before 9 a.m. or pay the meter.

The Borough reserves the right to tow any vehicle from the lower level of Lot 2 for failure to remove the vehicle from the lot once the permit has expired

NOTE: A citation may be issued with District Court 43-2-01 for parking tickets left unpaid after 14 days of issuance. Vehicles may be booted if there are 5 or more unsettled parking violations against the registrant left unpaid over 30 days of issuance.
