

## INVITATION TO BID

The Borough of Stroudsburg will receive sealed Bids online via the PennBid Program ([www.PennBid.net](http://www.PennBid.net)) for the following proposed work within the borough:

### NORTH 8<sup>TH</sup> STREET 2021 PAVING PROJECT.

All Bidding Documents, including specifications and bid sheets are available at no cost at [www.PennBid.net](http://www.PennBid.net).

The Scope of Work for the projectin comprised of the placement of concrete curb on the east side of 8<sup>th</sup> Street from Thomas Street to Spring Garden Street, mill & base repair of utility trench repair on North 8<sup>th</sup> Street, Spring Garden Street, and Somers Lane, and an asphalt, tack coat, scratch and leveling course and a 1.5” wearing course overlay on the entire length of North 8<sup>th</sup> Street from Thomas Street to Phillips Street. Access and maintenance and protection of traffic during construction, erosion control, restoration, and other miscellaneous items are also included. Bid alternates of tack coat, leveling course, and 1.5” overlay of Somers Lane from base bid tie in to Grove Street and of tack coat, leveling course, and 1.5” overlay of Grove Street from Somers Lane to Phillips Street will also be included.

Bidders must have the experience and qualifications necessary to perform this work.

All Bidding Documents are available at no cost at [www.PennBid.net](http://www.PennBid.net). Successful bidders are responsible for the PennBid fee. Documents will be available on PennBID beginning **July 7, 2021**

Bid proposals will be received until **3:00 o'clock p.m. prevailing time on Wednesday August 11, 2021** via PennBid program ([www.PennBid.net](http://www.PennBid.net)). Bids will be opened online. The bids summary will be reviewed by the Stroudsburg Borough Council at their meeting, at the Municipal Building located at 700 Sarah Street, Stroudsburg, PA 18360, on Tuesday, August 17, 2021 at 7:00 P.M.

A non-mandatory pre-bid conference for the Contract will be held on site at the intersection of North 8<sup>th</sup> Street and Spring Garden Street on Wednesday July 28, 2021 at 3:00 pm. – Borough Hall 700 Sarah Street in case of rain.

Bid security in the amount equal to 10% of the base bid amount in the form of cash, certified good faith check, cashier’s check, or irrevocable letter of credit drawn upon a bank authorized to do business in this Commonwealth, or by a bid bond with corporate surety made payable to or naming as obligee the Borough of Stroudsburg shall be submitted with each bid. Bidders shall upload a scanned copy of a fully executed bond as part of the online sealed bid submission. After the Bid Opening and upon request by the Owner, Bidder(s) shall provide an original hard copy of the Bid Bond. If providing security in the form of a certified check or bank money order, security must be delivered to the Owner prior to the Bid Opening date and time.

The successful Bidder will be required to furnish and pay for satisfactory performance and payment bonds in the forms provided in the bid specifications, each in the amount of not less than one-hundred percent (100%) of the awarded contract amount within 10 days of receiving notice of the bid award. An acceptable surety company is anyone included in the latest of the U.S. Treasury Department Circular 570 listings and authorized by the PA Department of insurance to do business in Pennsylvania. The successful bidder shall be required to submit evidence of insurance coverage with an insurance company having an A.M. Best rating of “A-: Class X” or better in accordance with the specifications.

Bidders shall note that not less than the minimum salaries and wages as set forth in the Contract Documents must be paid on this Project, and the Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, or national origin.

Bids may be held by the Borough of Stroudsburg for a period not to exceed forty five (45) days from the date of the opening of bids for the purpose of reviewing the bids and investigating the qualifications of bidders, prior to awarding the contract.

The Borough of Stroudsburg reserves the right to waive any defects, errors, omissions, irregularities or informalities in a bid or the bidding procedure and to accept any bid, which it may deem to be for or in the best interest of the Borough, and to reject any or all proposals.

The Borough of Stroudsburg does not discriminate based on actual or perceived race, color, religion, sex, ancestry, marital status, mental or physical disability, or the use of a guide or support animal and/or mechanical aids because of physical handicap, sexual orientation, national origin, gender identity or expression, age or familial status.
