## A Quick Reminder

To make life better for all residents, a quick reminder of some of the important "quality of life" Ordinances in Stroudsburg Borough. Rules are not to restrict your freedoms, but to infringing on the rights of others, making life more pleasant for all residents.

**Dogs.** We love dogs in Stroudsburg, but our Borough Code requires that dogs be on a leash at all times, have a current license, and owners must always clean-up after their dogs. Also, a law was just passed that allows us to cite owners whose dogs are excessively barking outdoors, for a period longer than 20 minutes.

**Fireworks.** Pennsylvania law now allows residents to purchase more varieties of fireworks, but that doesn't mean that they can be used anywhere. Fireworks cannot be used within 150 feet of any structure, with fines ranging from \$100 to \$1,000.

**Tenant Registration.** Like many communities in Pennsylvania, Stroudsburg requires that owners of rental properties provide the Borough with information on occupants in each dwelling unit. The Borough's Regulated Rental Unit Occupancy Ordinance provides needed safeguards for both landlords and tenants.

# Upcoming Projects in the Borough

## Stroudsburg Landmarks to Receive Major Upgrades

Stroudsburg Borough is fortunate to contain so many architectural and historic landmarks that make our community one that is not only exceptionally beautiful, but truly unique as well. Two of Stroudsburg's major landmarks are currently planning on extensive upgrades that will have a huge positive impact on the region over many years to come.

### Monroe County Historical Association Heritage Center

As a cultural and learning center, the Monroe County Historical Association seeks to build a Heritage Center adjacent to the Stroud Mansion to inspire and serve the public as the county-wide historical organization. The Heritage Center will increase opportunities to teach lessons of history that provide direction to the future and enhance the quality of life and appreciation of community and culture. The benefits of the Heritage Center project include:

- 1) A community room for expanded educational programs, workshops, lectures, special exhibits, and community events;
- 2) Providing accessibility for all residents;
- 3) Ensuring the preservation of Monroe County's valuable archives and artifacts, and;
- 4) Maintaining the integrity of the historic 1795 Stroud Mansion.



The renderings show the proposed architectural design of the Heritage Center. In keeping with guidelines from the United States Department of the Interior's Preservation Brief 14 and the Stroudsburg Historic Preservation District, the addition uses the same materials and a simplified design that references, but does not copy, the historic building.



### Monroe County Courthouse Plans Advance

The Monroe County Commissioners, in conjunction with the Judiciary, are continuing to advance plans to renovate, modernize and build an addition to the Monroe County Courthouse. The project, designed to provide a functional, safe, secure and dignified setting for the administration of justice, consists of three major components:

- A new three story addition housing an attractive entry lobby, service and secure vehicle access, and new courtrooms, chambers and support areas. The addition will be located on the east end of the block bounded by 6th, Monroe, and Sarah Streets.
- Interior renovation of the 1970's Courthouse Annex to provide additional courtrooms and more efficient use of space for court related agencies. While the Annex's exterior will remain as is, the existing sunken plaza will be redeveloped to create a new, more easily accessible and useable public plaza.
- Restoration of the interior spaces of the National Register listed Historic Courthouse including the 1893 courtroom, 1930's courtroom, library, entry lobby and public stair. New life safety and security systems will be installed along with areas of interior renovation to support court programs. Concrete sidewalks and retaining walls on the east side will be removed and replaced with lawn restoring the Courthouse's setting on Monroe Street to its original condition.



The Monroe County Courthouse has been a significant landmark in downtown Stroudsburg since the late 1800's and the new addition and entry plaza are intended to reinforce the prominent role of the courthouse in the community.

an officer with Airborne, Air Assault and Special Operations units.

Deciding to leave the military to again work in the arts, over a number of years Larry was executive director with six arts non-profits across the country. He discovered his true passion was in community building and economic development through the arts, in building collaborative partnerships that developed programs that improved the quality of life in the community. His work with the Arts Center in Jamestown, ND, is particularly noteworthy. The Arts Center was awarded the North Dakota Governor's Award for the Arts for their work in community building efforts; an award from ND Tourism for the Center's Arts Market, a weekly, outdoor arts-based community street fair anchored in a downtown pocket park; as well as a large grant from the Bush Foundation to explore further collaborative efforts in community building.

In late 2018, Larry decided to move from North Dakota back home to Northeast Pennsylvania to be near his elderly Mother and family. In spring 2019, he began working as the Borough Manager in his hometown of Catawissa. Taking the reins of a municipality that was without a manager for over a year, Larry put in place policies and procedures that increased efficiency as well as successfully completing several large infrastructure projects that were finished on time and under budget. Financially, all major funds finished with surpluses every year of his tenure.

"Working in municipal government brings together all of the disparate threads of my professional life," stated Kopp. "Leadership and management from my time as an officer in the military; creativity from my time as a performing musician; and consensus and community building from my experiences in arts management," states Kopp. "I am looking forward to working together with the Mayor, Council, residents and staff in growing our community and making it the best it possibly can be."

**Short-Term Rentals.** Short-term rentals, more commonly known as Airbnb's, are covered by an Ordinance and are regulated by the Borough. License are required for operation.

**Parking Permits.** Residents of residential districts are required to obtain parking permits to allow parking for longer than the time allowed by parking restrictions. Permit applications are available at the Borough office; proof of residency is required. Short-term permits are also available for visitors.

**Recycling.** The Borough of Stroudsburg requires recycling. Bi-weekly, curbside recycling pick-up is mandatory for all residents. The pick-up schedule is available on the Borough website. The Borough, in conjunction with East Stroudsburg, maintains the Twin Boroughs Recycling Center off of Lincoln Avenue for the convenience of residents.

**Alarm Registration.** Alarm systems on private property need to be registered with the Borough. Property owners wishing to install alarm systems must apply through the Borough Manager. Permits are not transferable.

## Mayor Tarah Probst First Female Mayor in Borough History First Elected in November 2015



I was born and raised in East Stroudsburg and have lived in northeast Pennsylvania all my life. I was raised by my mother, my grandmother and my aunt, along with my 3 brothers. I earned my Law degree from Widener University School of Law in 2003 and my Bachelor's degree from King's College in 1992. While I lived in the Wyoming Valley for some time, Stroudsburg was always home. I moved back to Stroudsburg in 2010 and in 2013 my husband and I bought our home in the beautiful borough of Stroudsburg.

I have spent my career in marketing, helping business owners grow and connect. My career has had me talking with people, understanding their needs and helping them. That is what I do, and I will continue to do it in government. In 2016 I left the corporate world and my husband and I opened up a downtown restaurant to support our town and to be a part of the community I was

newly elected to serve. We sold the Charcuterie on Main St. in September 2018 to Renegade Winery and so proud of what they have done. In 2019, I took a part time job as a Regional Account Coordinator at Brookdale Premier Addiction Recovery. I love getting people the help they need and I've learned so much through the process. I am so fortunate to love what I do for Brookdale and Stroudsburg Borough.

# The Shanti House Project

## Mixed Use Structure on Main Street Brings Benefits to the Community



The proposed Shanti House project at 621-623-625 Main Street is to construct a 65 feet tall, 5-story building containing 50 residential units and 2 commercial units with 17 off-street parking spaces.

Fourteen years ago, a fire of suspicious origin destroyed the buildings at 621-623-625 Main Street that formerly housed the Da

Vinci Cafe, Atomic Mary and Main Street Jukebox. Since that time, the lots have been empty, hidden behind a beautiful artist's mural.

The Shanti House Project has undergone close scrutiny from Stroudsburg's Borough's Historic Architectural Review Board to ensure that the new building will be a good architectural "fit" with the many historic buildings in the downtown district.

While the structure itself will be an architectural and aesthetic compliment to the downtown, there are many other benefits of this project to the community. A new, large structure will bring in increased property tax revenues to the Borough, County and School District, assisting with paying for increased services to residents. New businesses means new jobs, assisting in growing the local economy. The fifty units of housing means more business for downtown businesses and again, more tax revenues. Mixed use structures and traditional downtowns are the future of urban planning, and Stroudsburg Borough is on the "cutting edge" of urban development, working to make our community the best it possibly can be for our residents.

### Council Vice-President Matt Abell

As head of the Redevelopment and Codes committees, my

I'm proud of all the things Council has done to make life better for our residents: allowing sidewalk dining; penalizing blighted property owners; bringing app-based parking meters, solar-compacting trash cans, and bike racks to our downtown; streamlining the historic architectural review process; and enacting a non-discrimination ordinance. 2021 will bring other exciting changes, such as new bike lanes to Glen Park, initial planning for two new Creek Walk trails, an open space impact fee for new development, and mobile radar speed signs for our residential neighborhoods.

I watched my daughter learn to pedal a bike for the first time on our town sidewalks, grateful that she will grow up having a sense of independence that kids in gated communities never get to experience. It's the reason I'm a "town-mouse," and if I'm reelected to another term in the fall, I intend to keep building on the successes that make this such a wonderful place to call home.

I grew up in New York, like many Stroudsburgians. I attended Baruch College in the 1990s and later completed my degree at Kaplan (Purdue) in Legal Studies.
